Tax return: Ñea tax return ei form eran wō
nim erre ian me õmeatu ea bita Australian
Taxation Office (ATO) enim õmeata an
eimwi ñaben wō nimō pumwe, oa egen
enim pumwew tsin ia enim refund eiiuw.

Aña bet nim õmeatu wanga tax return?

Tsin ia ebeo am daein makur ea bita
PALM scheme inan auwe amebuna foreign
residents tax. Wō eō need ei wō nim
õmeatu memak wam tax return tsin ia
wō makur ea dorabat ion ian bita PALM
scheme.

Tsin ia wō makur ea bita PALM scheme
rōquo edae, wō nan metu ian bita tax ejen
ura ñabuna Australian residents. Wō nim
õmeatu õkör wam tax return.

Õten mwanin an makur?

Tsin ia wō makur, wō nan pumwe income
tax ean maramwum. Ñea bita income
tax uda ean bita obweni tekeijj am obu
maramwum.

Amea wō makur ea inan teidan etow
maramwum me inan send ejj ea Australia
Tax Office (ATO). Ñune ouga bwe inan Pay
as You Go (PAGYG). Ouga riringen bwe
enim eō ouwak wam tax tsin ia magen
eobweni. Inan auwe gona ät ian wam pay
slip ouwakin wam tax etow atsin turin ina
eñan am makur.

Egada dogin bita financial year, ATO inan
õdu memak PAYG emuk ñana bita etañ ino
wō makur ogiten uda atsin ian maramwun
ean bita eobweni. Ñune inan õmeata tsin
ia enim õredowanaw oa ijuw bet emuk wō
nimō pumwe ean wam tax.

Nan ATO gona refundeiyo?

Eab guaratanee ngana wō nan õgök tax
refund atsin turin ATO. Ekae memak
deidet engame, ibun ri nan gona tax
refund, ibut engame ri nan pumwe emuk
ea ATO. Wō nim eo expect ei nim tsimine
wam tax refund.

Etang ino wō nim õmeatu wam tax return?

Wō nan kanani ipuôk turin registered tax agent

Tsin ia wō teñej an puôk tax agent nim
õmamo me õmeatu wam tax return, oa
enim totow tax advice, wō nim owenõn
ñabuna register ian bita Tax Practitioners
Board (TPB). Wō gonan ñani ura ñabuna
tax practitioner ogiten register ian bita
TPB Register ean tpb.gov.au.

Tax agents oa professionals inan tsimine
pumwora wō nimō pumwe tekeij \$100 ea
\$200 re gonan omamo me õmeatu wam
tax return ian egõm. Metsimesti eaw
bwe wō nim kuda egen pumwen me enim
epo buriõum ea ian obwen am onuweiw
riringen wam tax return.


Lodgeiy nanga kor ATO – ko pumwan

Nan egen roquin daein õmamo en waña tax return?

Ebak ean muñana tax return õmamo online inan õbu **14 ibum ririñen**. Tsin ia ATO manual ririñen wam tax return, inan gona õbu 30 ibum nim og.

Tsin ia wō õmeatu wam tax return iat dabuch, inan gonan õbu 50 ibumin makur enim og ririñen.

Wō nan gonan aia ino tuk ririñen wam tax return ean am õdegeri muñane self-help egadauw:

- Ean bita ATO online myGov
- Ean wangara terepon (13 28 65 me select ei bita option 1 me og tuk 1).

Ikeget imin a need ei dōgin õmeatuen wam tax return?

Online income statements: Wō gonan bet āt online income statement ngea õmeata memak met ekamarawwi me tax wō ogiten pumwe ian bita financial year. Ngaben am makur gonan oijaw, oa wō gona ñoni ean bita ATO online ean MyGov.

Ijet dain am omeatu wam tax return

Õmeatu wam tax return iruwin an og wam income statement inan õmeata ñana 'tax ready'. Oija memak bwain makur ea **14 July** nim metun memak. Tsin ia wō õmeatu ian obwen bita 'tax ready', inon imin eab meta ean murana income statement inan tsiminen an eō eimwi me ñea inan õbun edae ririñen wam tax return.

Tsin ia wō teñ og ririñen wam tax return wo nim õmeatu oa arowõña tax agent ian obwen oa ean **31 October**. Tsin ia duōkun metu wam tax return inan gona fine eijuw.

Noted: wō nim õmaran nim update wam bank ian obwen am õmeatu wam tax return. Inan buōk ATO panaw me quoquon nim egadaw wam tax refund.

Levyeyen Wam Medicare

Tsin ia auwe resident ian Australia ñea õgök emuk ouwak ea \$24,276 ian bita financial year me wō eō metu ian bita Medicare towe Family Accompaniment Pilot Program, wō nim complet ej murana Medicare Entitlement Statement. Wō eab pumwe bita Medicare Levy tsin ia wō gona murana Medicare Entitlement Statement epoa agem me/oa ñaim (ia tsumine) ura bet õmeatu murana Medicare Entitlement Statement. Wo gona apply ea bita Medicare Entitlement Statement ean myGov oa riring murana online form. Enim eo dogin metu application eobweni eaeoweaew.

Wō nim ober ea am gona wam Medicare Entitlement Statement ian obwen am õmeatu wam tax return.

Deidein õmeatu en wam tax return

STEP 1

Óni wam income statement. Inan meta ean wan ATO Online bita MyGov iruwin 14 July.

STEP 2

Ia wō nim õmeatu online, naña bita ATO online ean MyGov me õdegeri muñana epanaw.

Ia eñame õmeatu aw tekeij (tax agent ngea register).

- Ónani tax agent ogiten register iat tekawa ino wō mek – wō ñan eko pumwen ian bita TPB public register.
- Ñaben am makur gona bet etotow ipuok dogin tax agent.
- Wō õmamo wam appointment oa naña bita eobid. Wō nan oija ura wam income statement epoa wam receipts.
- Nim garoau ngana nan gona timine pumwan. Ibu re oija wangara tax practitioner nim uda wan fee iat bita wam tax refund.

STEP 3

ATO ao amea wam tax agent nan panauw jiw oweiy ura ao nan timine wam tax refund. Noteiy: Jiaw oweiy ura nan wu needeiy contacteiyen ATO dugun pumweiyen am dura Wam refund eganon õbu **5 ibumin makur** enim egada wam muk ian wam bank account.

Ikegen ijuw am kuda
