Financial yia long Australia em inap long 12-pela mun stat long 1 July inap long 30 June.

**Takis toksave pepa:** Takis return em wanpela pepa bai yu raitim na salim i go long Australian Takis Ofis (ATO) long painimaut sapos haumas tru tax bai yu baim, o sapos bai ol i bekim moni bilong yu

## Bai mi mas mekim takis return?

Sapos yu wok ananit long dispela sotpela-taim PALM wok bai yu olsem wanpela foreign resident ananit long takis lo. Bai yu no mas mekim takis pepa sapos olgeta pe bilong yu long wok ananit long PALM scheme em wantaim wanpela kampani Gavman i oraitim ol. Sapos yu wok ananit long long-taim PALM wok bai yu mas wanpela residen long Australia ananit long lo bilong takis. Bai yu mas mekim takis return pepa Long kisim moa toksave, lukluk long dispela ATO webpage long PALM Scheme.

## Dispela i save wok olsem wanem?

Sapos yu wok, bai yu baim income takis long salary o pe bilong yu. Income takis bai ol i kisim wanwan taim insait long yia tru yu save kisim pe long en.

Kampani yu wok long en bai i rausim takis moni long pe bilong yu na salim i go stret long Australian Takis Ofis (ATO) long nem bilong yu. Dispela ol i kolin Pay As You Go (PAYG). Dispela ol i save wokim long helpim yu bai yu no inap kisim bikpela takis long pinis bilong wanwan yia. Bai yu luksave haumas takis ol i rausim long pe bilong yu long pe pepa ol i raitim na givim yu.

Taim financial yia i save pinis, bai ATO i skelim haumas PAYG kampani i rausim pinis long pe long dispela yia. Dispela em bai mekim ol bai save bai yu inap kisim tax moni bek o bai yu baim moa tax moni.

## Bai yu inap kisim bek moni long ATO?

I nogat ol i tok bai yu mas inap kisim bek moni long ATO. Olgeta manmeri i narapela kain, sampela manmeri bai kisim takis moni bek, na sampela pipol bai mas baim moa moni long ATO gen. Yu no ken ting bai oltaim yu kisim bek sampela takis moni.

## Bai mi salim takis pepa i go we?

**Panim halpim long wanpela registered takis agent.**

Sapos yu laikim wanpela takis agent bai stretim takis return pepa bilong yu, o halpim tingting bilong yu long takis, bai yu sekim olsem ol i register pinis wantaim Takis Practitioners Board (TPB). Bai yu inap sekim dispela TPB Register long bai wanpela takis practitioner em i register pinis o nogat.

Ol Takis agent o professional bai yu baim em olsem \$100 inap long \$200 long wokim na salim takis pepa long nem bilong yu. Yu mas askim pastaim long bai yu baim hausmas tru na yu mas wanbel long dispela pastaim yu statim stretim takis bilong yu.


**Sapos yu yet salim i go stret long Australia Takis Ofis (ATO) – bai yu nogat baim long dispela.**

Bai yu mekim dispela long ATO Online, bai yu inap link long MyGov akaun bilong yu. Dispela em yu no inap baim tasol yu yet bai wokim.

Yu inap long mekim takis return long pepa yu we yet wokim.

Wanem kain we tru yu yet mekim long salim tax return, tingim em yu yet responsible long wanem claim yu wokim. Yu mas mekim deduction long bihainim lo na mas tokaut long olgeta moni bilong yu pastaim long agent bai i salim return i go.

## Bai haumas taim long ol bai pinis long stretim takis moni bilong mi?

Planti ol takis return yu salim online em ol i save stretim insait long **14-pela** de tasol. Sapos ATO mas sekim tax pepa bilong yu wokim long pepa, yu mas wetim olsem inap long 30 de long calenda.

Sapos yu salim tax return long pepa tasol, nogut bai ol wokim inap long 50 de long woktaim.

Bai yu inap sekim olsem ol i wokim tax pepa bilong yu long dispela ananit hia:

- ATO Online long myGov
- Long fone sevis (13 28 65 na pikim option 1 na 1 gen bihain).

## Bai mi mekim wanem long salim takis pepa bilong mi i go long ol?

**Online income statements** Yu bai inap painim online wanpela income stetmen i soim haumas olgeta pe na tax you baim long dispela finansel yia Kampani yu wok long en bai soim yu long dispela, o yu yet lukim long ATO Online long MyGov.

## Wanem taim bai yu mas salim takis pepa go long ato?

Salim takis return pepa bilong yu i go long taim income stetmen bilong yu em '**tax ready**'. Planti ol Kampani ol gat taim inap long **14 July** long stretim dispela.

Sapos yu salim bipo long em i 'tax ready', ol samting long income stetmen nogut bai i no stret na em bai kisim sampela taim long ol long stretim tax pepa bilong yu.

Sapos yu mas mekim tax return orait bai yu mas givim long wanpela tax agent, bipo long **31 October**. Sapos yu salim tax return i go late, nogut bai ol i sasim yu.

Tingim: sekim gut ol adres na bank namba samting bilong yu em ol i stret taim yu salim tax pepa i go long ol. Dispela em bai halpim ol ATO long toksave long yu na salim tax refund i kam stret long yu.

## Baim bilong medicare

Sapos yu wanpela resident long Australia na ol peim yu antap moa long \$24,276 long finansel yia na yu no save kisim Medicare ananit long Family Accompaniment Pilot Program, bai yu mas raitim wanpel Medicare Entitlement Statement. Yu no mas peim Medicare Levy sapos yu kisim wanpela Medicare Entitlement Statement na man o meri na/o pikinini bilong yu (sapos i gat) em tu i gat wanpela Medicare Entitlement Statement. Bai yu inap askim long wanpela Medicare Entitlement Statement long MyGov o raitim wanpela online form long dispela. Wanpela nupela application yu mas salim i go olgeta narapela yia.

Bai yu wetim inap yu kisim Medicare Entitlement Statement pastaim long salim takis return bilong yu i go long ol.

## Ol we bilong salim tax return bilong yu

### NAMBA 1

Kisim insome stetmen bilong yu. Em bai yu kisim dispela long ATO Online long MyGov bihain long 14 July.

### NAMBA 2

Sapos yu **yet bai salim online**, plis go long ATO online long MyGov na bihainim toktok long en.

Sapos **narapela lain i salim i go** (wanpela registered takis agent).

- Painim wanpela registered takis agent long ples yu stap long en - yu inap painim long TPB public register.
- Kampani yu wok long en tu bai inap toksave long wanpela tax agent.
- Bai yu mekim appointmen o go long ofis bilong ol.
- Bai yu mas soim ol long income statement na/o ol receipt pepa.
- Yu mas save olsem bai yu baim ol lain long halpim yu long dispela.
- Sampela lain manmeri long halpim yu long takis samting bai orait long kisim pe long dispela i kam aut long takis refund yu bai kisim bihain..

### NAMBA 3

Ol lain long ATO o dispela agent i halpim yu bai toksave long yu olsem bai yu gat dinau long takis, o bai ol ATO inap bekim sampela takis bilong yu baim pinis. Tingim: sapos yu gat dinau, bai yu mas askim ATO long hau bai yu stretim baim bilong ol dispela dinau. Refund bilong yu bai inap long 5-pela bisnis de long go insait long bank akaun yu tok pinis long en.
