Ia wo magur ian Aotoreria nan bita etangan am magur inan pumwe super 11% ean maramwum animwen bita maramwum wo reit ogok. Bita wam super inat pumwe ian bita wam superfund wo ijij, inan emek ina ea ngaga wo claim eijin iruwin am redo bwiom.

Ean roquin am magur, tsimine woun wo nim check ei tsin ia bita engan am magur oreit pumwe bita wam super nega eimwi enim pumwe eaw. Etangan magur enim pumwe wam super ean quarterly (ibun re iji nim wang pumwe en)

NB. Bita 11% Super Guarantee inan ngabeda dugun 0.5% eobweni aeoweaeow aweijida 1 July 2023 ea an egada 12%. Bita 11% inan pudu ea 30 June 2024

## Ijet edae a gona claim ei wanga super?

Wo gona apply enim pumwe eaw wam superannuation tsin ia:

- Wo ogiten erowi Aotereria me expire oa cancel wam visa
- Tsin ia ekeowen wam visa bwain Aotereria, tekei tamo earit visa (epoa tourist visa) me
- ia deo auwe citizen in Aotereria oa New Zealand oa deo auwe premanent resident ian Aotereria.

Ngaga wo eo gona omeatu wam claim dugun wam super ngaga wo reit mek Aotereria, ma **metsimetsiw** wo nim onani me memori ean wo nim awei riringen wam application ian obwen am erowi ina. Wo nim nanga bita 'what information do need to claim DASP'. Inan kejeija ian wo riring ngaga wo erowin ina.





Wo gona baida wam DASP online account ian obwen am erowi Aotereria. Wo nim riring wam DASP claim ean am nanga bita DASP online me baida wam 'shared secret'. Bita wam shared secret nan gona omeatuw wo nim riring wam claim ia wo redo eow bwiom, me ia expire oa cancel wam visa. Ian obwen am erowi Australia, checkeiy daein an mag wam visa. Nan wo gona metu ian Visa Entitlement Verification Online (VEVO) system bwe wo nim check ei angogen wam visa.

## Me ed tsin a babwiji visa ngarana roquo?

Ia awe engame nea ebeo am daein magur me wo babwiji visa ngarana roquo daein wo nan eab gona claim ei wam super ea am redo eow bwiom me expire wan visa. WO NIM EO cancel ei murana a multi-year visa eaden an mag memak am magur ian Aotereria. Tsing ia wo cancel ei, wo nan tuk pumwe visa tsieduw ia wo nimo redo me egona bet eo oijaw wam visa.

## Otuwan pumwe en DASP?

Nan pudu pumwe em inimagen 28 ibum ia complete wam application. Application for payment nea eo og riring oa missing dabuch in inan duoku riring. Imin eimwi wo nim omag riring wam application.

Inan gona pumwe wam super ian tambo bank ian **Australian awe wo nim gadauw details**, oijonaw cheque, oa pumwe ea International money transfer (ibun fund applications). Ebak bank aton eo accepteiy wan cheque Australia me ko bet 3 erun nuwauwin pumwe et emuk. Ian obwen am erowi Aotereria, check ei wam super dugun riringen pumwe en. Tsing iaa wo teng **ENIM** pumwe wam super ian wam bank account ian Aotereria wo nimo ngaina wam bank ian Aotereria baida dugun bitune Australian bank account.

Tsing ia wo eo claim eiy wam DASP ean 6 maramen ian obwen an mag daein wam visa, in gona eomemori wam super eaeow bita ATO nea inan babwiji ea claim eijen. Super ian ATO **nan ta** pumwe eadu iat Australian bank account oa oijonaw iat post ian cheque ian Australia dollar.

Wo nim dorer ea wam super fund ian obwen am erowi Australia bwe wo nim aia iket dabuch ri nan teneiy iow iturum.

Eimwi ia wo certify ei wam dabuch turin amebuna approved certifier ngaga wo tuk Australia. Wo gona bet check ei turin wam ngabet emagur oten mwanin am gona certify wam dabuch.
